DEFINITIONS AND SPECIFIC CONDITIONS

MUSIC RANGE	(A) Phonograms (cd, music files, streaming etc); (B) Radio/tv (A included); (C) Music video (A/B included)
PRICES	VAT is added at 6%. The prices follow the development of the consumer price index – base month is July previous year – and is regulated every year on January 1. If the music used predominantly consist of music videos (C) the price will be twice the class A price. Minimum price dance: 627 SEK / year, other areas: 232 SEK / year.
LOUNGE	The music fee is charged when there is no music in the hotel rooms.
RESTAURANT	Full day refers to opening for more than five hours. Half day five hours/ day or less.
DANCE	Music at discos, night clubs and other venues where dance can occur, for example, when bar DJs are engaged, and pause music played when the live band/orchestra break.
REPORTING	Hotels report rooms, dancing guests and workout sessions with a leader twice a year. A reminder will be sent out by SAMI and the reporting can be made on our website: sami.se/musikredovisning or by sending in the appropriate form. If the report is made after the specified date SAMI will charge an administrative cost of 500 SEK plus VAT to cover the extra administration.
